IRS Verification of Non-Filer Letter Request Process

An IRS Verification of Non-filing Letter provides proof that the IRS has no record of a filed Form 1040 for the year you requested.

This process is free of charge and can be done in one of two ways – online or by mail. The IRS Verification of Non-filer letter should be sent directly to you and submitted along with Washington University's Non-Filer Worksheet and W-2's (if applicable).

Online Request available at www.irs.gov/individuals/get-transcript.

- Click "Get Transcript Online" (If at any point, you cannot validate your identity for example, you cannot provide
 financial verification information or you lack access to a mobile phone you may use Get Transcript by Mail, see
 below)
- Select "Higher Education/Student Aid" for the reason you need a transcript.
- Select 2022 under "Verification of Non-Filer".
- Print or Save this document and submit with Washington University's Non-Filer Statement, along with any W-2s if applicable. Be sure to include the student's ID number on each document.

Paper Request Form - IRS Form 4506T

- Form can be downloaded https://www.irs.gov/
- Search "IRS Form 4506T". Complete lines 1 4, following the instructions on page 2 of the form.
- Do not complete Line 5. Verification of Non-Filer letter must be sent to the parents or student and submitted with Washington University's Non-Filer Statement.
- Check the box at the end of row 7.
- On line 9, enter the year-end date you are requesting. For the 2025-2026 FAFSA you would enter 12/31/2023.
- Check the box above signature, enter your phone number, and sign the form.
- Please mail the completed form to the IRS. Page 2 of the IRS 4506-T gives directions on where to mail the form based on the state in which you live. Below is the same information as provided on page 2 of the form:
